



FINAL ACQUISITION PAYMENT - ISSUE OF SECURITIES

Variscan Mines Limited ("**Variscan**" or the "**Company**" or the "**Group**") (ASX:VAR) is pleased to announce the issue of 4,000,000 ordinary fully-paid shares to Slipstream Resources Investments Pty Ltd (AFT The Slipstream Capital trust) in satisfaction of the outstanding consideration payable for the acquisition of the Spanish Zinc assets, acquired in December 2019.

Under the terms of the acquisition agreement, the Company has previously issued 58,279,412 (post-consolidation) shares to the vendors of the assets, and this issue of 4,000,000 shares satisfies the final component of the acquisition consideration.

The acquisition agreement contains provisions for the payment of 29,926,471 milestone shares upon the satisfaction of each of the following milestones, for a total of 58,852,942 milestone shares:

- Milestone 1: The definition, in accordance with JORC 2012, of an Inferred Mineral Resource (or greater) of 4 Million tonnes at 7% Zn
- Milestone 2: The definition, in accordance with JORC 2012, of an Inferred Mineral Resource (or greater) of 8 Million tonnes at 7% Zn

To date, neither of these milestones have been met.
