ISSUE OF SHARES FOLLOWING PLACEMENT AND NOTICE UNDER SECTION 708A(5)(e)

We refer to the announcement by PlatSearch NL (PlatSearch or the Company) made on 9 March 2005 of a placement of 4,055,000 ordinary shares at a price of 8 cents per share to raise \$324,400. The shares issued pursuant to the placement rank equally in all respects with all existing ordinary shares previously issued by the Company. The funds raised in the placement are being used to provide working capital and to meet the costs incurred in mineral exploration and project generation.

Issue of PlatSearch Shares – Secondary Trading Notice Pursuant to Section 708A(5)(e) of the Corporations Act 2001 (“Act”)

On 14 March 2005, PlatSearch issued 4,055,000 fully paid ordinary shares (“Securities”) to local investors.

Secondary Trading Exemption




